JACKPOT RAFFLE

RULES/GUIDELINES

The following will go into effect on or before January 1, 2020

1. The Jackpot Raffle will be administered by the elected Officers of Springfield Post #32, The American Legion and additional Post 32 members appointed by the Post Commander which will comprise the Jackpot Raffle Steering Committee. All decisions made by these individuals regarding the Jackpot Raffle will be final.
2. You must be 18 years of age or older to participate in the Jackpot Raffle. You must also show valid identification when claiming your winnings.
3. Drawing will be every Monday at 7 p.m. at American Legion Post 32, 1120 Sangamon Avenue, Springfield, Illinois under the direction of the American Legion Post 32 Jackpot Raffle steering committee. Any disputes regarding the administration of this raffle, the Jackpot Raffle steering committee shall have final authority.
4. Tickets are \$1 each or 6 for \$5. These tickets will be single roll style. You must purchase a minimum of one ticket and print legibly your name on each ticket purchased. After the 2nd chance drawing on Tuesday evening, all tickets will be destroyed, and you must purchase new tickets for the next weeks drawing. Ticket color may be changed each week.
5. The Jackpot Raffle board will have 100 squares on it, with one unknown square being the Jackpot Raffle.
6. If your ticket is drawn and you are present, you will pick one square on the Jackpot Raffle Board. If this is the JACKPOT SQUARE, you will win as follows:
 - a. Week 1 – 5 of the board 50% of the jackpot
 - b. Week 6 – 10 of the board 60% of the jackpot
 - c. Week 11 – 15 of the board 70% of the jackpot
 - d. Week 16 – 20 of the board 80% of the jackpot
 - e. Week 21 – 25 of the board 90% of the jackpot
 - f. Week 26 and on 100% of the jackpot.
 - g. If the square you pick is not the jackpot square, then you will win \$200.00 cash
No additional tickets will be drawn for that board.
 - h. You must be present to win.

7. Jackpot Raffle tickets will be sold for the following week immediately after the 7 p.m. drawing.
8. We will NOT have a dollar cap on each board. When the Jackpot Raffle Board is hit, another Jackpot Raffle board will start at \$5,000.00. Per the I.R.S., tax forms will be completed on winners of \$1,000.00 or more. Winnings over \$5,000.00, tax forms will be completed, and tax withheld from the winnings. *(The Post Finance Officer, Adjutant and Accountant will provide necessary tax forms and instructions that are to be used for the winners).*
9. The proceeds from the sale of tickets will be to:
 - a. To pay the winnings in items 6 above if the Jackpot Raffle is not hit.
 - b. The remaining funds, one half will go to American Legion Post 32 and will be placed in a Special Raffle Account and the remaining one half will increase the Jackpot Raffle by that amount for the next week.
10. The Jackpot Raffle will be licensed by Sangamon County as a Raffle and taxes will be paid to the Sangamon County Clerk.
11. Bartenders, Post Officers, Jackpot Raffle Steering Committee members and those designated by the Jackpot Raffle Steering Committee will sell tickets at the Post for the weekly drawings.
12. The Jackpot Raffle Steering Committee will, immediately following the drawing, post the following information at Post 32:
 - a. Post the names of the winner(s) and amount won.
 - b. Date of the next drawing.
 - c. Amount in the Jackpot Raffle(s) for the next dates drawing.
 - d. Week designation of the board.
13. These guidelines may be modified as determined by the Officers of Springfield Post #32, The American Legion and the Jackpot Raffle Steering Committee.
